

OFFICIAL NOTICE OF RATE CHANGE FOR MAY 1, 2018

This document is an Official Notice that includes specific legal language and information for members/consumers about a change in electricity rate tariffs.

On February 22, 2018, the MiEnergy Cooperative Board of Directors approved a change in electric rate tariffs affecting prices for electricity service that you receive. This will apply to your electricity consumption beginning May 1, 2018.

The increase in annual revenues to the cooperative is projected to be 1.5% based on historical energy sales. Changes in the rate tariff components such as the basic service charge and kilowatt-hour (kWh) charges, increased and decreased as part of the transition to the MiEnergy Cooperative rate format from the former Tri-County Electric Cooperative rates. The last rate change for members was May 1, 2012.

The impact of the rate change on your bill will vary depending on the energy consumption and season of consumption with the former seasonal energy rates. Members may also be moved to a new rate class depending on their electric service size (kVA) and energy use. Accounts with transformers sizes greater than 50 kVA will be subject to a minimum bill charge of \$1 per kVA of required transformer size. The new rate tariffs are listed below.


